

Motion Promotion 2026 Barksdale Federal Credit Union One Winner Will Receive Up To \$25,000.00 (twenty-five thousand dollars) Toward Their Qualifying Auto Loan Balance Giveaway. No obligation necessary to enter or win. Non-obligation entries and obligation entries have an equal chance of winning. Members entering without obtaining a qualifying auto loan are eligible to win a separate cash prize of \$2,500 (two thousand and five hundred dollars). Promotion is open only to legal residents of the fifty (50) United States and the District of Columbia age 18 and over who are members of Barksdale Federal Credit Union. Promotion begins at 8:30:00 a.m. Central Time on June 1, 2026, and ends at 5:00:00 p.m. Central Time September 30, 2026 (“Promotional Period”). Drawing will take place on the afternoon of November 17, 2026. There are two (2) ways to enter: **1.) Automatic Entry:** An eligible Barksdale Federal member will automatically receive one (1) promotional entry for each new auto loan account (account type: 60-01, 60-03, 61-02, 61-04, 62-01, 62-03, 63-02, 63-04, 64-01, 64-02, 65-01, 65-02, 66-07, 66-08, 66-01, 66-02, 68-07, 68-08, 68-01, and 68-02) opened at Barksdale Federal Credit Union under eligible member’s name during the promotional period. Loan is considered “opened” when fully funded and active on the Sponsor’s system. Each qualifying loan receives one entry. Only the primary borrower listed on the qualifying loan account will receive the promotional entry. Certain restrictions may apply to opening an auto loan account. Minimum new deposit of \$5 may be required. See Barksdale Federal eligibility requirements and Barksdale Federal auto loan account requirements. **2.) To enter without obligation by U.S. Mail:** Existing Barksdale Federal members may enter the promotion without obligation via U.S. mail by hand-printing your name, address, city, state, ZIP code and telephone number (including area code) on a 3”x5” card and mailing in a #10 envelope with postage affixed to: Motion Promotion 2026 Barksdale Federal Credit Union Giveaway, 2701 Village Lane, Bossier City, LA 71112. Mail entries must be received by noon on September 30, 2026, in order to be eligible. Mail entries will not be eligible for payment of previous auto loans or auto loans not with Barksdale Federal Credit Union. Limit one mail-in entry per envelope. Limit one mail-in entry per member. **Prizes/Values:** One (1) winner participating in the giveaway will be chosen to win the following prize described herein: BFCU Member’s Auto Loan Opened at Barksdale Federal Credit Union between June 1, 2026– September 30, 2026, will have remaining loan balance as of November 17, 2026, paid up to \$25,000.00 (twenty-five thousand dollars). Only the amount of the outstanding loan balance, up to \$25,000 will be paid. The winner will not receive any amount over the balance of the loan. Total Estimated Retail Value of the Grand Prize is up to \$25,000.00. Prize value may vary depending on outstanding loan balance. Only the outstanding principal loan balance as of November 17, 2026, up to a maximum of \$25,000, will be paid by Sponsor. Interest accruing after payoff processing, ancillary products, fees, negative equity, and any amount exceeding \$25,000 are the responsibility of the winner. Prize will be applied directly to the qualifying loan balance and will not be awarded as cash except as otherwise expressly stated herein. If a mail entry only participant is drawn, the winner will receive a check for \$2,500 or a \$2,500 (two thousand and five hundred dollars) deposit into his or her account at Barksdale Federal Credit Union **Odds:** Estimated odds of winning the Grand Prize are determined by the number of entries. **Sponsor:** The sponsor of the promotion is Barksdale Federal Credit Union.

### **Winner Selection and Notification**

One winner will be drawn at random on November 17, 2026. You need not be present to win. In the event that the prize is payoff of an existing loan, the balance up to the prize maximum will be paid and the winner notified. If the winner does not have auto loan with Barksdale FCU, a Credit Union employee will call the prize winner, and the prize winner will be called up to five times during regular business hours at number provided on entry form. Failure to reach winner during these calls may result in disqualification of winner, forfeiture of his or her interest in all prizes, and selection of a substitute winner drawn at random. Prizes are non-assignable and nontransferable. No substitutions allowed by winner. Prizes and individual components of prize packages are subject to availability and the Credit Union reserves the right to substitute prizes of equal or greater value.
